REPORT OF OFFICERS AND SPECIAL GUESTS

Police Department – Chief Studer was absent but Mayor Arington explained the Chief is thinking about parking one of his police cars because the cost of maintenance on it is so high.

UNFINISHED BUSINESS

Ordinance 08-009 – **Amend Stop Sign Ordinance --** The public hearing was opened and closed. Councilmember Gilmour moved to approve ordinance 08-009 and Councilmember Turpin seconded the motion. The motion passed 4 yes and 0 no. In addition, a map will be attached per section 1 of the ordinance.

Discussion of yard waste fees – A couple of suggestions were to charge \$5.00 per load and display a sign at the dump site. Councilmember Gay moved to approve only commercial dumping at \$10.00 per ton and residential to continue by donation only.

Councilmember Gilmour disagreed with this. Councilmember Turpin and Councilmember Camarata both agreed that we should also charge a residential fee. Councilmember Gay amended his motion to be a commercial dumping fee of \$10.00 and a residential fee of \$5.00. Councilmember Turpin seconded the motion. The motion failed. Councilmember Turpin moved to approve a flat dumping fee of \$5.00 until the end of the year and put up a sign. Councilmember Gilmour seconded the motion. The motion passed 4 yes and 0 no.

NEW BUSINESS

Vacant Council Position – Councilmember Huber hasn't submitted a letter of resignation but has resigned by default as she has taken the County Commissioner position. Mayor Arington announced he will advertise for this vacant position.

Parks – Councilmember Turpin would like to create a volunteer Parks Committee to help with the upkeep of the parks. Council agreed this would be a great idea. Councilmember Gay suggested concentrating on one park at a time.

Councilmember Gilmour suggested when watering the parks to set the sprinklers so they don't hit the buildings.

Court Clerk – We will be interviewing at least two applicants tomorrow evening. The other two haven't been set up yet.
