### APPROVAL OF PAYMENT

**Approval of December Bills** – Checks #14288 to #14305 for \$109,636.98 were moved to be approved by Councilmember Huber and seconded by Councilmember Helland. The motion passed 4 yes and 0 no.

### MAYORS REPORT

**Vance Heating Maintenance Agreement** – Council agrees that we should be able to do this work ourselves, which includes being able to change filters and apply grease. The school does their own maintenance on their system. Councilmember Huber requested having the Mayor discuss this in more detail with Cal Jordan, the architect. Council would also like to check with Brad and Burke on this.

**City Hall Remodel** – Hopefully we will be in the remodeled City Hall by the end of January. Councilmember Huber would like us to plan a well prepared open house. Councilmember Hink would like to tour the remodeled building.

# **COUNCIL DISCUSSION**

**Ending Fund Balance** – Councilmember Huber discussed the summary of the ending fund balances over the past several years. She suggested we do the transfers quarterly instead of annually that are scheduled in the 2011 budget (general fund to street and library). Councilmember Hink requested we separate out the city hall gas from electric. It was suggested to watch this line item and if there appears to be an issue in 2011, take another look at it and possibly separate it out at that time.
