#### **REPORT OF OFFICES AND SPECIAL GUESTS**

#### A. Staff Reports (informational only)

#### Brenda Bach – Waste Water Treatment Plant

#### 1. <u>Water Department-</u>

a. Waiting to hear from Gray & Osborne on the schedule for painting the water tower. I'm sure it will be soon.

b. We had to change out the chlorine gas cylinder at the tower. This was the first time since we had the new chlorine injector installed, and went very smooth and easy. By following the strict change out procedures manual which came with the new injector system, we learned a new safety procedure that was not originally in our previous change out procedures manual. We've always have safety our number one concern since the chlorine gas is so toxic/deadly to breath, every extra safety step we can implement creates the safe working environment we strive for.

#### 2. Cross Connection Control Department-

a. No new news

#### 3. <u>Wastewater Department-</u>

a. We've had some issues with the Benton Lift station lately with the control module which we trouble shooted and re-set programming. Working correctly now, and will be doing our fall maintenance ,cleaning and inspection soon before school starts up with minor repairs to the interior wet well.

b. Will be scheduling time for the Vactor truck and doing some preventive maintenance on the grit channel, and re-aeration basin. This preventative maintenance is very important for these 2 basins because the settled solids/grit has no-where to go and it builds up in the bottom and creates more process problems, and added ammonia levels which make it hard to meet our discharge permit acceptable levels set forth by the Department of Ecology.

c. It's that time of year to disassemble the fine screen and replace the worn out parts and oil changes that keep it operating and doing the much needed garbage removal out of the process plant. Since the fine screen was installed back in 2011 the plant doesn't have the issues it had in the past dealing with all the garbage and plugging up the butterfly valves which are designed to deal with "Clean" water, not water full of garbage/rags. Which we had to deal with before, because the only garbage process we had at the time was a grinder that just barely shredded the garbage/rags and pushed it through the plant which caused all kinds of operational issues.

- 1. We have two qualified applicants for the open "Lateral" Police Officer Position. I have personally reached out to each applicant and informed them I anticipate interviews to take place the week of July 17<sup>th</sup>. If one of the two applicants is chosen to move forward, a conditional job offer is anticipated around the first of August. An extensive background check will take place to include a polygraph and psychological exam prior to determining an official start date. \*In the absence of a third Officer, myself and Officer Taylor have been "on-call" for many off duty hours. We have not experienced excessive call out's which is fortunate, however, being "On Call" too much has obvious negative impacts on a person. We are both looking forward to a new third officer.\*
- 2. Patrol Vehicle Logos are scheduled to be ready and installed towards the end of July. They will be similar to the picture below. Again, I have chosen maroon logo's to support our local school colors and offer distinction from other agency vehicles.

#### Scott Moore – Public Work Lead

- Our May ended with a water line repair on the Clerf main line, so June 1<sup>st</sup> was cleaning up after the mess and loading service truck with permanent tools to carry. Zirkle Fruit's construction on Pacific Loop got into full swing & needing service connections, (that will be completed within the next 2 weeks by us.)
- We installed water service out in Rainier Estates, prepped for circus which seemed to go fairly smooth.
- My helper, Kash Sansaver gave his 2 week notice on account of wanting to do something different.
- We got the paving project coordinated and completed on the last day of operating engineers training period.
- We gave our interview to the Daily Record on our community projects.
- We moved the rented out-house to Palmerio Park (\$30.00 more for a month vs. 2 days for paving project)

- We had a water main service leak at 203 E. 1<sup>st</sup> Street. We excavated the line and found corroded pipes to be the problem with no corporation stop (service line shut of valve) and the 4 valves on the main line to isolate area, one has a malfunction, so long story short shut down water tower to install new service and corporation stop and returned water service to town.
- We have been utilizing a citizen volunteer to assist with mowing & irrigation.
- Have been planning ways to stream line park care. Example: in-ground irrigation at Palmerio Park. Just installing pop up sprinkler heads, saves more than 1 hour on watering time. I am still waiting for bid return on this.

### **UNFINISHED BUSINESS**

#### A. All-Terrain Vehicle Ordinance

- Mayor Whitford explained that Chief Nierman tailored the Ordinance for the use of all-terrain vehicles on sidewalks only for snow removal. All state law requirements must be used when operating an all-terrain vehicle in City limits. They must have lights, blinkers, protective eyewear etc.
- Councilmember Smith stated that all rules apply the same as owning and operating a vehicle.
- Councilmember Cort asked about insurance requirement. You are required to have it licensed for all roads and have proof of insurance.
- Councilmember Gilmour thinks this Ordinance is ridiculous, kids will be racing and the City is opening a can of worms.
- Councilmember Smith stated that the same protections are in place as a vehicle and she would defer to Chief Nierman decision and his research with the City of Cle Elum, Councilmember Smith feels confident the City can handle the Ordinance.
- Citizen Bryant is in agreeance with Councilmember Gilmour that it is unsafe and children could get hurt, there are currently issues with small motorcycles on the streets with kids. The Bryant's do use their 4-wheeler to plow snow in the winter.
- Mayor Whitford stated that we should be good neighbors and keep eyes open for problems.

**MOTION:** Councilmember Camarata made a motion to approve Ordinance 17-009; second by Councilmember Smith. Motion Carried: 4 yes 1 no (Councilmember Gilmour).

#### B. Ordinance 17-012 Kittitas Volunteer merger with KVFR

- This Ordinance was previously passed as a Resolution and per County Auditor it needs to be an Ordinance. The Ordinance is stating the City of Kittitas intent to merge the Volunteer Fire Department with Kittitas Valley Fire and Rescue. This Ordinance will be placed on the November ballot for the citizens to decide.
- Councilmember Smith stated that Council was not for or against this Ordinance this is just putting it on the ballot for the Citizens of Kittitas to have the opportunity to decide if this is what they would like.
- Councilmember Cort felt this was good clarification.

#### A. 17-010R Surplus Printer

• This Resolution is to surplus two printers that no longer work and no longer have parts available to fix them. They are of no value.

#### B. MOU (Memo of Understanding) Pacific Loop Lights/PUD

• Public Utility District is drawing up a Memo of Understanding with the City of Kittitas and Pacific Loop stating that the City of Kittitas is responsible for the payment of the electricity for the lights.

MOTION: Councilmember Camarata made a motion to table the MOU until it is presented

from PUD; second by Councilmember Cort. Motion Carried: 5 yes 0 no.

#### C. 17-011 Budget Amendment

- This does not affect the budget monetary wise just line descriptions in each fund. The 3/10's fund wages were increased for 100% of the wages of the Code Enforcement Officer. And the General Fund will have the lease payments for the two new patrol cars.
- Councilmember Gilmour inquired about wages not being built up and why we needed to do the amendment, it was explained that yes the wages are fine since the City is down an officer, but there are two sides a budget and actual. This ordinance is for the budget side of things.

### MAYOR'S REPORT

- Mayor Whitford informed Council that the Chamber and the City will start to have weekly meeting for the burnouts in August which is only one month away.
- There are 23 swap meet slots for people to register for. The rate is \$20 and Mayor Whitford would like the money raised to go towards banners for Main Street using the design of the re branding that the Chamber is working on.

- Mayor Whitford thought maybe a booth at the local fair.
- Councilmember Cort would like to have a planning committee meeting so they can talk about the zoning issues in the Central Business District.
- Councilmember Cort is attending the AWC Budget training in Leavenworth Thursday and Friday of this week and will bring information back to Council.
- The Friends of the Depot have numbered and pictured all items in the depot. They will put the inventory into an excel spread sheet, Cathy Doyle is working on organizing the newspaper articles that were in the depot.
- Councilmember Cort stated that she had found an old power point presentation on the Garden Committee and would like to get people involved with this project again. They had applied for a Quadco grant for the walking path, BBQ areas and gazebo and this was denied but maybe they could apply again in smaller sections and not one giant request.
- Councilmember Cort is still working on the grant from Home Depot on the Community Hall/Library stair project. This grant could be as much as \$5,000.
- Councilmember Gilmour asked if he could proceed with taking the carpet out as this is a tripping hazard. Council gave him approval.

- Councilmember Smith has been doing a lot of research and figuring out what is pertinent.
- Councilmember Smith said she would like to be a part of the Parks and Garden Committee possibly but would like to help with the City of Kittitas Facebook Page and can hopefully get more volunteers thru social media. These people don't want a formal role with government but possibly help were it is needed.
- Councilmember Smith inquired as to how much the carpet would be to replace, Councilmember Gilmour said the material is about \$400 this is not the installed portion.
- Councilmember Gilmour thought maybe there was something better besides carpet as when it gets wet from the elements it get slick and maybe there is a paint process that has more traction for different weather conditions.
- Councilmember Cort reminded Council that they can be on committees as an oversite person.
