BUSINESS LICENSE FEES

In accordance with the City of Kittitas Business and Occupational tax ordinance, this application form is being sent to you to facilitate the securing of a valid business license.

The annual license fee is collected from every business or person engaging in a business activity within the City of Kittitas.

Listed below are the license fee rates.

Employees	
1 to 2	\$35.00
3 to 4	\$60.00
5 to 6	\$85.00
7 or more	\$110.00

The above Business License fee schedule applies to all businesses located inside / outside the City of Kittitas, furnishing or performing services within the City.

Applications for business license during the course of the year are prorated according to the following schedule.

January to March	100%
April to June	80%
July to September	60%
October to December	40%

Business licenses are due and payable January 1st of each year and expire December 31st of each year. Any person engaging in business within the City of Kittitas without a valid license shall be subject to penalties as provided in Title 5 of the Kittitas Municipal code.
